## DESCRIPTION

Tucked away on a quiet 1.9-acre cul-de-sac lot in Hidden Valley and surrounded by mature trees and forest, 1061 Hidden Valley Court offers rare privacy with exceptional space and upgrades throughout. Recently remodeled, this home features an open-concept main living area anchored by a chef's kitchen with a large center island, a six-burner stainless steel range, new cabinetry, and Taj Mahal quartzite countertops. The main level also includes a breakfast space, a formal dining room, and a second formal living area. Additional downstairs highlights include a walk-in pantry with quartzite counters and open shelving, an executive office, an oversized utility room, and a fifth bedroom currently used as a workout room. The isolated primary suite features a spacious walk-in closet, dual vanities, a garden tub, a tiled shower, and private access to the back patio, which is wired for a hot tub. A recent addition above the garage provides a third living area, ideal for recreation or media space, along with an oversized bedroom and full bath with hall access. Upstairs in the original portion of the home are two additional bedrooms, each with its own en suite bathroom, plus an additional living space dedicated to these bedrooms. The backyard is a true retreat, featuring an extended patio, a recently built swimming pool with a tanning ledge, and a guest house with a kitchen, full bath, and living and sleeping areas. Additional amenities include a circular drive, an extended driveway, an expanded three-car garage with workshop potential, a 50-amp 240-v car plug-in in the garage, a propane tank for appliances, updated lighting, and luxury vinyl plank flooring. Located in Midway ISD, this property offers 5+ bedrooms, multiple living areas, 5+ bathrooms, and unmatched privacy in Hidden Valley.
