DESCRIPTION

Extraordinary luxury lakefront retreat on Cedar Creek Lake, tucked away on a private, gated peninsula with only a handful of homes—where privacy, craftsmanship, and water access meet. Set on 1.7 acres with 300+ ft of lake frontage, offering room for an ADU or shop, 360° lake views (including deep-water views across the street), and direct access to a protected, multi-creek-fed cove that typically stays wet during low season—providing quiet water away from heavy boat traffic. A golf cart path leads directly from the home to the boathouse. Designed for refined living and entertaining, this home offers 4–5 bedrooms, 3.5 baths, and approx. 3,500 sq ft. Four bedrooms are on the main level, including the primary suite, while the upper level provides a 5th bedroom or flexible game-media space. Interiors showcase elevated finishes including imported Taj Mahal Quartzite countertops, handmade inset Shaker cabinetry, and a custom imported wallpaper mural. Architectural highlights include 17-ft ceilings, vaulted spaces, 8-ft five-panel doors, Lifeproof luxury vinyl flooring, porcelain tile baths, and curated fixtures. The kitchen features a separate prep kitchen-pantry, while an independent wet bar with wine chiller enhances entertaining. The primary suite offers a spa-inspired bath with dual vanities, soaking tub, crystal chandelier, expansive walk-in closet, and sliding exterior door. Outdoor living includes a large covered patio with wood-burning fireplace, copper rain gutters, lake-fed irrigation, and a private boathouse. While lake levels fluctuate, this cove typically allows year-round boat access. Nearby amenities include fishing pier, picnic areas, playground, swimming access, and boat ramp.
